**PROJECT SUMMARY:** On July 30, 2024, the City Council of the City of Sausalito adopted a resolution of formation to establish the Downtown Sausalito Property Business Improvement District (DSPBID). The DSPBID is a property-based assessment district, which has been established for a 5-year period by property owners within the DSPBID area. The purpose of the DSPBID is to provide and manage activities, services, and improvements for Downtown Sausalito by working as a unit to fund needed property and business-related improvement programs, services, and programs above what is currently provided by the City of Sausalito and that provide benefit to DSPBID properties.

**WHAT WILL HAPPEN:** The Interim Board for the Downtown Sausalito Property Business Improvement District (DSPBID) will meet to review and discuss the creation of an events subcommittee, receive a report out and workplan update from the Infrastructure Improvement, Branding, Waterfront, and Administration subcommittees, receive an update on the PBID disbursement agreement, receive an update on the Year 1 Assessment Roll Invoices and Collections, and receive public comment.
