**PROJECT SUMMARY:** Amy Chan and BDE Architecture on behalf of SY Jardines Look Out LLC have filed applications for Design Review, Encroachment Agreement, Tree Removal and Vesting Tentative Map for a proposed 19-unit condominium complex, divided into two structures, and associated site and street frontage improvements on two existing lots. This project is subject to the Housing Accountability Act -Government Code 65589.5.

**CEQA DETERMINATION:** : An Initial Study was prepared in accordance with the California Environmental Quality Act and State CEQA guidelines and it has been determined any identified environmental impacts can be mitigated to a less than significant level and a Mitigated Negative Declaration may be adopted.
